## **INFORMATION AGENDA**

1. Refinancing the building opportunity – Mrs. Bernhard stated that we had been approached by a representative from the Royal Bank of Canada in regards to refinancing the bonds we currently have. The interest rate on our bonds is about 7.25%. With interest rates lower now, we are investigating the possibility of lowering our interest rate.

## **COMMITTEE REPORTS**

<u>Building Committee</u> – Mrs. Bernhard stated that we are getting bids to replace the carpeting in some of the classrooms, soundproofing the media center conference room, and moving a wall to give Mrs. Ginn (7<sup>th</sup>/8<sup>th</sup> grade science) more room.

Mr. Howe further stated that 3 ACs have been ordered, but we do not anticipate receiving them before the end of June, or even later.

<u>Teacher Representative</u> – Becky Schell stated that teachers and students are looking forward to summer break. She thanked Mr. Gaenicke for his role in allowing the F22 Flight team to present to our Sculptor students. It was an excellent presentation!
